Official Rules

Times/Dates:

1. **Promotional Date: Every Thursday; 8AM – 10PM**
2. **Entry Activation Times & Dates: N/A**
3. **Drawing Times & Dates: N/A**

Eligibility:

1. Eligibility will be limited to Saracen Player’s Club Members who received the mailer and have a valid, government issued photo ID
2. Banned individuals are not allowed to participate in any promotion at Saracen Casino Resort
3. The following persons shall not be eligible to participate in this promotion:
 - a. Any person under the age of 21
 - b. Any current employee of Saracen Casino Resort, including employees of any Quapaw Nation gaming facility
 - c. Elected and appointed officials of the Quapaw Nation

Kiosk Game requirements:
